SPARTAN x FITNESS FIRST x MYZONE CHALLENGE TERMS & CONDITIONS

- 1. SPONSOR. The Fitness First x Spartan World Championship Myzone Effort Points (MEPS) Challenge ("The Spartan World Championship MEPS Challenge") is sponsored by Fitness First (Leisure Unlimited LLC).
- 2. ELIGIBILITY.
